4. FIRST AID MEASURES

For advice, contact a doctor.

As a general rule, in case of doubt or if symptoms persist, always call a doctor. NEVER induce swallowing in an unconscious person.

In the event of splashes or contact with eyes:

If in eyes, hold eyelids apart and flush the eye continuously with running water.

Continue flushing until advised to stop by a doctor, or for at least 15 minutes.

In the event of splashes or contact with skin or hair:

Remove all contaminated or stained clothing immediately. Do not use them again until they have been decontaminated. Flush skin and hair thoroughly with running water. DO NOT use solvents or thinners. If the contaminated area is widespread and/or there is damage to the skin, a doctor must be consulted or the patient transferred to hospital

If on skin, remove any contaminated clothing, wash skin thoroughly with soap and water, then methylated spirit if available. Contact a doctor.

In the event of Inhalation:



If inhaled, remove from contaminated area. Apply artificial respiration if not breathing. In the event of swallowing:

If swallowed, do NOT induce vomiting. Avoid giving milk or oils and transfer to hospital immediately by ambulance. Show the label to the doctor.

5. FIRE FIGHTING MEASURES

Special risks:

Combustible. May evolve toxic fumes in fire. (formaldehyde vapours) Vapour/air mixture explosive. Keep away from sources

of ignition.

Suitable extinguishing media:

Foam, dry powder or carbon dioxide

Wear chemical protection suit and respiratory protective equipment immediately. Prevent fire fighting water entering

watercourses or ground-water.

6. ACCIDENTAL RELEASE MEASURES

Personal precautions:

Avoid any contact with the skin

and eyes. Avoid inhaling.

Consult the safety measures listed under headings 7 and 8.

If a large quantity has been spilt, evacuate all personnel and only allow intervention by trained operators equipped with safety apparatus.

Environmental precautions:

Prevent any material from entering drains or waterways. Use drums to dispose of waste recovered in accordance with applicable regulations (see heading 13). If the product contaminates waterways, rivers or drains, alert the relevant authorities in accordance with statutory procedures

Methods for cleaning up:

Clean preferably with a detergent, do not use solvents.

If this ventilation is insufficient to maintain the concentration of vapors below the exposure limits, wear breathing Hand protection:

Protective creams may be used for exposed skin, but they should not be applied after contact with the product. Where there is a risk of contact with the hands, suitable gloves must be used

Eye and face protection:
